**AMENDED FINAL JUDGMENT
AND
ORDER OF DISMISSAL
WITH PREJUDICE**

This matter came before the Court for hearing on March 27, 2009, pursuant to an Order of this Court dated December 23, 2008, on the application of the Settling Parties for approval of the settlement set forth in the Stipulation of Settlement dated as of August 11, 2008 (the "Stipulation"). Due and adequate notice having been given of the settlement as required in said Order, and the Court having considered all papers filed including letters objecting to the proposed settlement, together with the arguments of counsel and testimony at the hearing; and

The Court finding, for reasons set forth in the Opinion of March 31, 2009, as amended herein, that the certification of the proposed Class is appropriate and that the proposed settlement, as amended favorably to the Class members at the hearing, should be approved as fair, reasonable, and adequate pursuant to Rule 23(e), Fed. R. Civ. P.; and

The Court further finding, upon joint application of counsel

for the Settling Parties by letter dated May 8, 2009 (Docket Item 302) that it is necessary to correct editorial errors in the Final Judgment (Docket item 300) and in the Opinion (Docket Item 298) to correct the class definition of the approved class as well as the number of potential class members opting out (reduced from 202 to 195);

IT IS, this 27th day of **May, 2009**, hereby

ORDERED, ADJUDGED, and DECREED that:

1. The Final Judgment and Order of Dismissal with Prejudice, filed herein on March 31, 2009 (Docket Item 300) is hereby AMENDED as set forth in full herein.

2. This Court's Opinion filed March 31, 2009 (Docket Item 298) is hereby AMENDED as follows:

a. On page 11, third line from bottom of text, delete "202" and insert "195";

b. On pages 25-26, delete the class definition and insert:

"All MedQuist transcriptionists who transcribed for MedQuist from November 29, 1998 to August 11, 2008 and who were paid on a line-based unit of measure for their work. Excluded from the Settlement Class are those persons who timely and validly requested exclusion from the Settlement Class pursuant to the Notice of Pendency and

Proposed Settlement of Class Action identified in Exhibit A to the Amended Final Judgment and Order of Dismissal with Prejudice.”

3. This Judgment incorporates by reference the definitions in the Stipulation, and all terms used herein shall have the same meanings set forth in the Stipulation.

4. This Court has jurisdiction over the subject matter of the Litigation and over all parties to the Litigation, including all Members of the Settlement Class.

5. Except as to any individual claim of those 195 Persons (identified in Exhibit A attached hereto) who have validly and timely requested exclusion from the Settlement Class, the Litigation and all claims contained therein, including all of the Released Claims, are dismissed with prejudice as to the Named Plaintiffs and the other Members of the Settlement Class, and as against each and all of the Released Parties. The parties are to bear their own costs, except as otherwise provided in the Stipulation.

6. Pursuant to Rule 23 of the Federal Rules of Civil Procedure, this Court hereby approves the settlement set forth in the Stipulation¹ and finds that said settlement is, in all

respects, fair, reasonable, and adequate to, and is in the best interests of, the Named Plaintiffs, the Settlement Class and each of the Settlement Class Members. This Court further finds the settlement set forth in the Stipulation is the result of arms'-length negotiations between experienced counsel representing the interests of the Named Plaintiffs, the Settlement Class Members and the Defendants. Accordingly, the settlement embodied in the Stipulation is hereby approved in all respects and shall be consummated in accordance with its terms and provisions. The Settling Parties are hereby directed to perform the terms of the Stipulation.

7. Pursuant to Rule 23 of the Federal Rules of Civil Procedure, the Court hereby certifies, for purposes of effectuating this settlement, a Settlement Class of:

"All medical transcriptionists who transcribed for MedQuist from November 29, 1998, to August 11, 2008, and who were paid on a line-based unit of measure for their work. Excluded from the Settlement Class are those Persons who timely and validly

Integrity ["AHDI"] Peter Preziosi, Ph.D., in one respect, to take into account the passage of time by enlarging the time period within which Class Members may enroll in the AHDI offerings identified in Attachment A ("AHDI Program Offerings for Medquist Employees") to the Agreement. Specifically, wherever the Stipulation or Agreement or Attachment A to the Agreement refers to a deadline for Class Members to avail themselves of the AHDI offerings listed therein, such as by requiring a course "to be completed by December 31, 2009," the deadline is amended to read that such a course or other offering is "to be selected by July 1, 2010."

requested exclusion from the Settlement Class pursuant to the Notice of Pendency and Proposed Settlement of Class Action identified in Exhibit A to the Amended Final Judgment and Order of Dismissal with Prejudice." The Persons who timely and validly requested exclusion from the Settlement Class are listed in Exhibit A, hereto, consisting of 195 names.

8. With respect to the Settlement Class, this Court finds for the purposes of effectuating this settlement that: (a) the Members of the Settlement Class are so numerous that joinder of all Settlement Class Members in the Litigation is impracticable; (b) there are questions of law and fact common to the Settlement Class which predominate over any individual questions; (c) the claims of the Named Plaintiffs are typical of the claims of the Settlement Class; (d) the Named Plaintiffs and Plaintiffs' Counsel have fairly and adequately represented and protected the interests of all of the Settlement Class Members; and (e) a class action is superior to other available methods for the fair and efficient adjudication of the controversy, considering: (i) the interests of the Members of the Settlement Class in individually controlling the prosecution of the separate actions; (ii) the extent and nature of any litigation concerning the controversy already commenced by Members of the Settlement Class; (iii) the desirability or undesirability of continuing the litigation of these claims in this particular forum; and (iv) the difficulties

likely to be encountered in the management of the Litigation.

9. Upon the Effective Date, the Named Plaintiffs and each of the Settlement Class Members shall be deemed to have, and by operation of this Judgment shall have, fully, finally, and forever released, relinquished and discharged all Released Claims against the Released Parties, whether or not such Settlement Class Member executes and delivers a Proof of Claim and Release form.

10. Upon the Effective Date hereof, each of the Released Parties shall be deemed to have, and by operation of this Judgment shall have, fully, finally, and forever released, relinquished, and discharged the Named Plaintiff, each and all of the Settlement Class Members, and Plaintiffs' Counsel from all claims (including Unknown Claims), arising out of, relating to, or in connection with the institution, prosecution, assertion, settlement or resolution of the Litigation or the Released Claims.

11. This Court finds, for the purposes of effectuating this settlement, that the Association for Healthcare Documentation Integrity ("AHDI") is an appropriate recipient of funds as contemplated in the Stipulation. Upon the Effective Date Hereof, the funds shall be paid to AHDI as contemplated in the Stipulation, and AHDI shall fully comply with its obligations under the Stipulation and Agreement.

12. The distribution of the Notice of Pendency and Proposed Settlement of Class Action and the publication of the Summary Notice as provided for in the Order Preliminarily Approving Settlement and Providing for Notice, together with the follow-up efforts to locate all persons for whom the original notice had been returned, constituted the best notice practicable under the circumstances, including individual notice to all Members of the Settlement Class who could be identified through reasonable effort. Said notice provided the best notice practicable under the circumstances of those proceedings and of the matters set forth therein, including the proposed settlement set forth in the Stipulation, to all Persons entitled to such notice, and said notice fully satisfied the requirements of Federal Rule of Civil Procedure 23, the requirements of due process, and any other applicable law.

13. Any request submitted by Plaintiffs' Counsel or any order entered regarding the reimbursement of reasonable expenses shall in no way disturb or affect this Final Judgment and shall be considered separate from this Final Judgment.

14. Neither the Stipulation nor the settlement contained therein, nor any act performed or document executed pursuant to or in furtherance of the Stipulation or the settlement: (a) is or may be deemed to be or may be used as an admission of, or evidence of, the validity of any Released Claim, or of any

wrongdoing or liability of the Defendants; or (b) is or may be deemed to be or may be used as an admission of or evidence of, any fault or omission of any of the Defendants in any civil, criminal or administrative proceeding in any court, administrative agency, or other tribunal. Defendants may file the Stipulation and/or this Judgment in any other action that may be brought against them in order to support a defense or counterclaim based on principles of res judicata, collateral estoppel, release, good faith settlement, judgment bar or reduction, or any other theory of claim preclusion or issue preclusion or similar defense or counterclaim.

15. Without affecting the finality of this Judgment in any way, this Court hereby retains continuing jurisdiction over: (a) implementation of this settlement and any award or distribution of the Settlement Fund, including interest earned thereon; (b) disposition of the Settlement Fund; (c) hearing and determining applications for attorneys' expenses in the Litigation; and (d) all parties hereto for the purpose of construing, enforcing, and administering the Stipulation, including AHDI, its officers, and directors.

16. The Court finds that during the course of the Litigation, the Settling Parties and their respective counsel at all times complied with the requirements of Federal Rule of Civil Procedure 11.

17. In the event that the settlement does not become effective in accordance with the terms of the Stipulation or the Effective Date does not occur, or in the event that the Settlement Fund, or any portion thereof, is returned to the Defendants, then this Judgment shall be rendered null and void to the extent provided by and in accordance with the Stipulation and shall be vacated and, in such event, all orders entered and releases delivered in connection herewith shall be null and void to the extent provided by and in accordance with the Stipulation.
